TO THE CITIZENS OF THE MEMBER STATES  
OF EUROPEAN UNION AT LNGS

**Subject:** Law Decree 6<sup>th</sup> February 2007, no. 30 on the right of citizens of the Member states and their family members to move on and stay in the Member states of European Union, at discretion.

A brief summary of Law Decree 6<sup>th</sup> February 2007, no. 30 is reported below. For any further information on the subject, refer to Dr. V. Fantozzi (fantozzi@lngs.infn.it).

*Art. 6*

**Right to stay up to three months.**

Citizens of any of European Member states\* can stay, at discretion, in any of the Member states territory without any formal duty and/or condition up to three months. A valid identity paper (ID card, passport etc) that allows the owner to go abroad is required.

The same rules apply to family members who do not have a European Member states' citizenship and who are going to accompany or join a citizen of any of European Member states. A valid passport and visa (only if visa is needed to enter the Country) are required.

**Right to stay longer than three months and administrative formalities.**

Citizens of any of European Member states, who are entitled to stay in any of the Member states territory longer than three months (e.g. working reasons, sufficient financial resources etc.), will have to register themselves to the Commune Registry Office (Ufficio Anagrafe del Comune). Registration to Registry Office is required for stays longer than three months.

Family members of European Member states' citizens with:

a) citizenship of any EU Member states and who do not have any right to stay more than three months can get registered at the Registry Office too, providing some additional documents (valid ID paper, family statement etc.);

b) foreign citizenship can apply for "Carta di soggiorno di familiare di un cittadino dell'Unione" ("Residence paper for family member of a EU Member state citizen").
